In the coming months, PAO Case Info will undergo a substantial upgrade to improve the user experience and ease of use. This document is intended to provide you with a preview of the upcoming changes.

The main page after you login will change to the below which will have a list of your referrals, calendar of upcoming court dates, and new “Quick Nav” search bar.

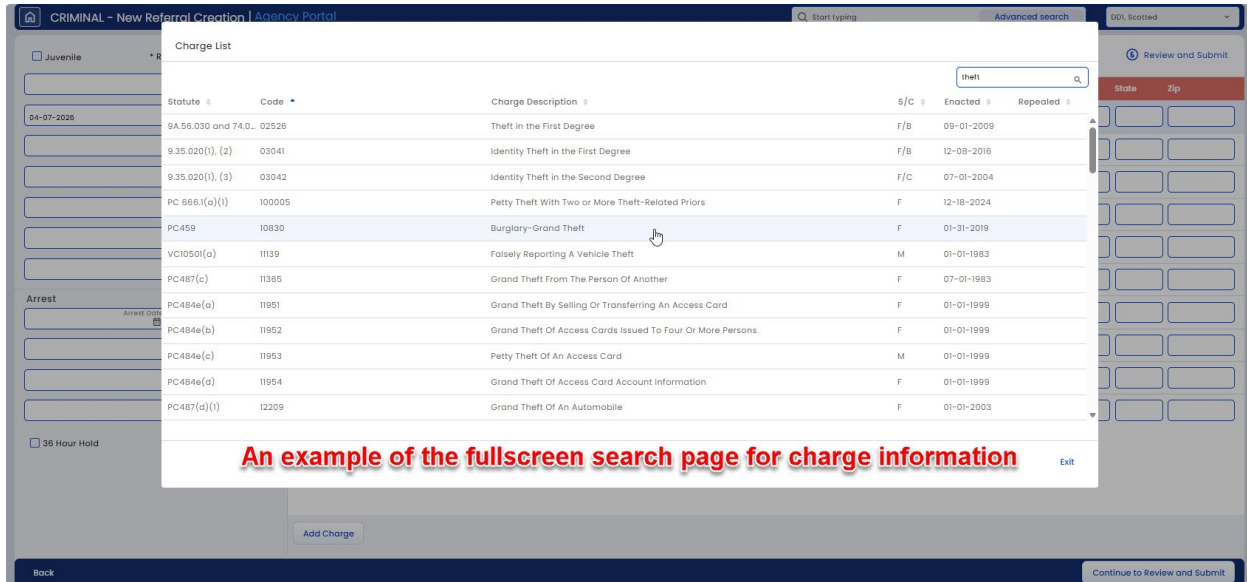

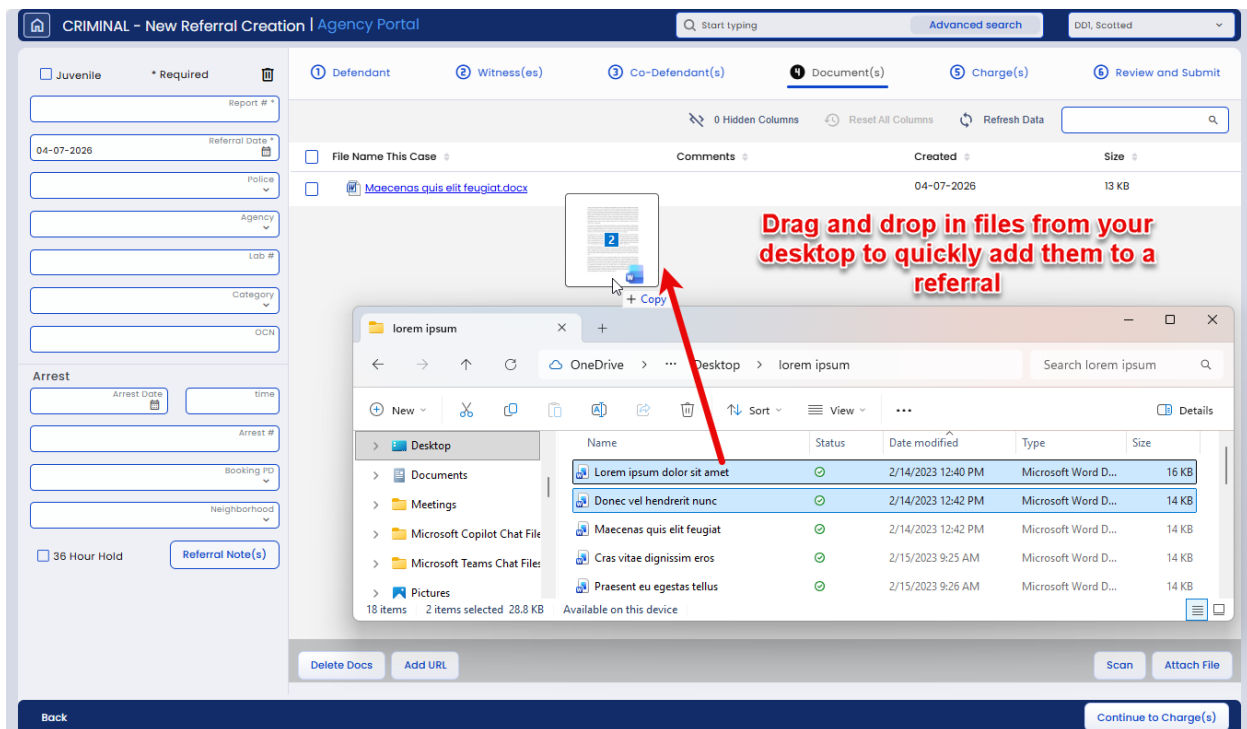
